

AGREEMENT FOR STALLION SERVICE AUCTION DONATION

The undersigned, stallion owner/agent hereinafter known as Donor, donates, at no cost, to the Paso Fino Horse Association, Inc. 101 North Collins, Plant City, Florida 33563-3311, hereinafter known as PFHA, one (1) stallion service (breeding) to the stallion listed below for the 2010 breeding season January-December 2010: this service is to be auctioned by PFHA during the 2009 Grand National Championship Show and **through March 31st, 2010.**

This stallion service donation is for the 2010 breeding season, subject to the following:

1. Stallion must be registered with the PFHA and stallion owner(s)/agent(s) must be a current member(s) in good standing, with the PFHA.

2. The stallion service will be auctioned by silent open bidding at the 2009 Grand National Championship Show held in September at the Georgia National Fairgrounds & Agricenter, Perry, Georgia. Any stallion receiving a bid by Nationals or during the National Show sells at the close of the show. All remaining stallions will be offered on the PFHA web site and through the Paso Fino Horse World until March 1st of the next year, sold for the first payment in full. If a stallion has not received a bid by March 1, the stallion owner can attain the stallion's offspring eligibility to the Breeder Sweepstakes classes by contributing an eligibility fee of \$200 by March 31. This fee will also entitle the owner to enter one offspring of their stallion in the Breeder Sweepstakes without paying the nomination fee. They would only have to pay the National class entry fee.

3. A STALLION'S 2009 DONATED BREEDING MUST SELL THROUGH THE STALLION SERVICE AUCTION FOR THE STALLION'S OFFSPRING TO BE ELIGIBLE FOR THE 2012 BREEDER'S SWEEPSTAKES. THIS ELIGIBILITY MAY BE GAINED BY: (A) A SUCCESSFUL BID DURING THE GRAND NATIONAL SHOW, (B) A SUCCESSFUL PURCHASE OF A BREEDING PRIOR TO MARCH 1ST, OR (C) THE PURCHASE OF ONE FREE NOMINATION BY THE STALLION OWNER.

4. The Donor is subject to all the conditions of PFHA Stallion Service Auction Agreement, and the policies and rules governing the Stallion Service Auction and Breeders Sweepstakes.

5. ***The Donor is to provide a copy of the breeding contract file to Mary Rizo Patron (address, provided below), or to the PFHA office Attention to the SSA/BS not later than July 15th, 2009.*** The sale of the stallion service (breeding) will be subject to this breeding contract and when signed by the Donor and the Bidder becomes a binding contract between Donor and Bidder.

6. In return for the donation and purchase of each stallion service (breeding), Donor receives a free nomination to the Breeders Sweepstakes for a foal sired by this stallion and conceived in 2010.

7. If said breeding purchased through the Stallion Service Auction, for valid reasons does not conclude in a successful breeding, ***the breeding may be rolled over to the following year*** with approval of the Chair of the PFHA Futurity Committee.

8. Donor will provide a breeding contract to the final Bidder. ***The contract will be binding between the Donor and the Bidder to protect both parties from unnecessary expense*** for either Donor or Bidder.

9. Donor will be notified by PFHA within 30 days of the sale of the breeding.
