### AGREEMENT:

2. The (Judge)(Steward) agrees to perform the usual and customary duties required of the position in accordance with, and subject to, the PFHA rules and regulations in effect at the time of the show, which rules and regulations are incorporated herein by reference.
3. The (Judge)(Steward), by signing this Agreement, acknowledges that he or she is familiar with the PFHA rules and regulations governing (Judge)(Steward) and specifically those governing conflicts. The (Judge)(Steward) represents that he or she is not aware of any existing or potential conflict with respect to officiating at said show and agrees to bring any such conflict to Association's attention immediately should any arise.
4. The (Judge)(Steward) agrees to be present at the show grounds by \_\_\_\_\_ o'clock on \_\_\_\_\_, in order to confer with show management and be ready to officiate.
5. The Association hereby agrees to pay the (Judge)(Steward) the sum of \$\_\_\_\_\_ per day, for a total of \$\_\_\_\_\_, for the services. The Association agrees to reimburse the (Judge)(Steward) for the following expenses actually incurred in connection with officiating at said show: Those incurred in traveling to the show (including coach air fare or mileage at \_\_\_\_\_ cents per mile) from his/her home, and return, or from, and to, other point(s) agreed to, lodging for \_\_\_\_\_ nights and meals during the period described in Section 1. Unless otherwise agreed upon by the parties and included within this Agreement, all expense reimbursements shall be made upon completion of the services and upon the submission to the Association of proper documentation of such expenses.
6. The Agreement may be amended, postponed or canceled by the mutual consent of the parties hereto. In such event, a notation thereof must be endorsed on this Agreement, dated and signed by the parties.
7. This Agreement may, for good cause shown, be canceled by either party upon giving to the other written notice thereof, at the address shown below, not less than ninety (90) days prior to the commencement of the aforesaid show. In the event a show is canceled less than ninety (90) days prior to its scheduled commencement date, the (Judge)(Steward) shall be entitled to payment of the fee specified in Paragraph 4 above.
8. The Association hereby affirms that this Agreement is executed pursuant to a Resolution duly adopted by its Board of Directors approving said Agreement and authorizing its President to execute the Agreement in the name of the Association.
9. The following special requirements are imposed upon and agreed to by the (Judge)(Steward) and the Association in connection with the services and show:
