**SHOW RULES & IMPORTANT INFORMATION**

**•It is important to PFHA that everyone in our shows has the best experience possible. If you have any needs which we could address in advance to make your experience better, please contact Sergio Garcia at 786-402-2092. If you have any ADA accessibility issues, you can reach the show facility at 305-299-2667. Please include**

**with entry if you have any mobility issues requiring parking close to stalls or arena.**

- **ALL fees must be paid & paperwork completed before exhibitor back numbers are released.**

- **4% credit card processing fee added to all credit card transactions.**

- **ALL horses will be charged a stall fee. NO grounds fees available**

- **50% refund will be issued for class entry fees with vet certificate after 11/18/24. Horses that submit a certificate in order to receive a refund will not be allowed to show in this event.**

- **\$100.00 handling fee will be charged for all returned checks/declined credit cards.**

- **CLOSE OUT: Failure to close out show bill on the last show day, Sunday, 11/24/24 will incur an added \$50.00 to your show bill.**

- **If show bill is not paid in full, returned check or declined credit card is not paid in full within 2 weeks after notification, PFHA will be immediately notified of the non-compliance!**

**PLEASE READ ALL FEES ASSOCIATED TO SHOW!**

- **ALL exhibitors must enter the arena when called by gatekeeper. It is your responsibility to be in warm up arena 30 minutes before your class! Barn calls are a courtesy!**

- **ALL arenas will close one hour after the show ends and 2:00 am curfew for all parties and loud music at barns! Horses need to rest! Be considerate of Horses and neighbors!**

- **Show Management reserves the right to combine classes if less than 3 entries in a class.**

**SHOW MANAGEMENT RESERVES THE RIGHT TO REFUSE ENTRIES.**

**•Exhibitors are notified that any act of discourtesy or disobedience to the judges, officials or show staff, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee, other fees and may be asked to leave showgrounds.**

**•Dogs must be on a leash on showgrounds.**

**• As per Park Management rules no vehicles will be allowed in the barn area. Vehicles must park in the allotted parking spaces north of the arena. This rule will be strictly enforced. NO EXCEPTIONS!**

**GOLF CART RENTALS:**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
