#### Robin Ratliff (PFHA Life Member No. 832)

My family's journey and commitment to the Paso Fino started in 1966 in Ft. Lauderdale, Fla. We were involved in breeding and showing Quarter Horses. Our first glimpse of the breed came when Angel and Carmen Usategui (Cepero), introduced us to their Paso's while boarding at our ranch. My parents were so amazed watching the horses work and they were completely enthralled with the smoothness of the gait.

A few months later, my Mother traveled to Puerto Rico and returned home with a buckskin mare named "Atenas." She had the natural gait and smoothness that is the hallmark of our breed. Slowly but surely, the Quarter Horses were sold to different homes and we started acquiring Pasos. In 1967, at a local auction, there were three Pasos from Colombia being auctioned. That night, we bought El Pastor who would become one of the Paso Fino Horse Association's six Foundation Sires. He was Sire of the Year seven times and on the Top Ten Sires list 20 times, just to name some of his accomplishments.

Although very young, I remember vividly how tenacious and steadfast the early Paso owners and breeders were at that time in establishing the breed here in the United States. Without their efforts, I don't think we would not be here today.

In 1972, the Paso Fino Owners and Breeders Association, PFOBA, was founded. In the mid-80s, we changed our name to the Paso Fino Horse Association, (PFHA). We are an affiliate of the United States Equestrian Federation (USEF) and CONFEPASO. Most importantly, we established our own registry.

My experiences and influence comes from the founding members of our Association and always guides my decisions. It was, and still is, our responsibility as members, to serve the Association as volunteers. We ran shows. Held clinics. Started regions and road in parades. We did nearly everything and anything to promote and expose our breed.

We all believed that if the PFHA was succeeding, we as breeders and owners would succeed as well. Our PFHA Constitution reminds us, we are a member owned and member governed association. Every member is of equal importance.

For my part, I am a Life member of PFHA. I am a professional trainer. I hold a judges card in both the PFHA and USEF. I was named the 1989 Trainer of the Year. I was awarded the C.J. Cronan award from the USEF in 2002. Most recently, I was honored to be inducted into the PFHA Hall of Fame. My Mom and El Pastor were inducted into the PFHA Hall of Fame much earlier, as they should have been.

I have served on the PFHA Board of Directors as President, Treasurer, the Executive Committee and as a Regional Delegate for the North Florida Region. I have been appointed or elected to serve as the Chair of the Executive Committee, Chair of the Finance Committee, Chair of the Judges and Stewards Committee, Chair of Geldings Committee and Chair of the Communications Committee. I have been fortunate to serve on many other PFHA committees with some very hard working members.

For rules concerning Absentee Ballots, please refer to the Paso Fino Horse Association Sept. 1, 2024 Rule Book, Constitution, Article VII, Section 9, Voting, B, Membership Meetings. "At Membership meetings, instead of a member's vote being voted through his or her Regional Group Director, that person (who has been a voting member of the Association for a period of thirty (30) days prior to the meeting) shall be allowed to attend and vote as an individual or he/she may vote by Absentee Ballot or by Proxy as stated in C., below. In such cases, his or her name shall be deleted from the Regional Membership list for voting purposes as applicable."

Paso Fino Horse Association 2024 Rule Book, Constitution, Article VII. Meetings, Section 9, Voting, C.1., p. 34, "An Absentee Ballot may be used only for the election of officers. Official notification of the meeting, including agenda and the form for the Absentee Ballot, must be made to the membership at least 3 weeks prior to the meeting. All Absentee Ballots shall be completed according to the requirements stated on the ballot, shall be filed with the Association at least 10 days before the meeting, and shall show the member's Regional Group affiliation."

Complete ballots with original signatures must be <u>RECEIVED</u> by the PFHA Office at the address above no later than <u>at least 10 days in advance</u> of the Annual January board meeting.
